## Become a Bowmoor Benefactor

Bowmoor would like to continue to improve the facilities available to members. Much has happened in the last year and there are further plans to improve both site and equipment. Inevitably, this requires capital.

Bowmoor Sailing Club is a registered Community Amateur Sports Club. As such it is eligible to receive Gift Aid donations from taxpayers which are enhanced by HMRC. Simply, every £1 donated to the Club is increased to £1.25 by HMRC. Further, the donation can be used to offset individuals own tax liability. If you're a higher rate taxpayer, you can claim additional tax benefits for the donations you make to charity worth another 25% of the donation.
